

Terms of Service

1. Your Acceptance

This is an agreement between BNTouch, Inc., a Oregon corporation ("BNTouch"), the owner and operator of sites including the BNTouch CRM, ProsOnWeb.com, and BestInMortgage.com (the "BNTouch Sites"), the software, including downloadable apps (collectively, including all content provided by BNTouch, the "BNTouch Service", or the "Service"), and you ("you" or "You"), a user of the Service. BY USING THE SERVICE, YOU ACKNOWLEDGE AND AGREE TO THESE TERMS OF SERVICE, AND TO BNTOUCH'S PRIVACY POLICY (<http://bntouch.com/agreements/> and <http://bntouch.com/privacy-policy>), WHICH IS INCORPORATED HEREIN BY REFERENCE ("Terms of Service" or "Terms"). If you choose to not agree with any of these terms, you may not use the Service.

Throughout these Terms of Service, certain features, sites and content within the Service may be referred to expressly. If you do not use that portion of the Service please disregard those terms as they are not applicable to you.

BNTouch reserves the right to update and change the Terms of Service without notice. Any new features that augment or enhance the current Service, including the release of new tools and resources, shall be subject to the Terms of Service. Continued use of the Service after any such changes shall constitute your consent to such changes. You can review the most current version of the Terms of Service at any time at: <http://bntouchmortgage.net/TermsOfService/>).

Violation of any of the terms below will result in the termination of your Account. While BNTouch prohibits such conduct and content on the Service, you understand and agree that BNTouch cannot be responsible for the content posted on the Service and you nonetheless may be exposed to such materials. You agree to use the Service at your own risk.

2. Specific Services

A. BNTouch CRM Service

If you, or your employer, subsidiary, affiliate, or parent, have subscribed to the BNTouch Mortgage CRM services these Terms of Service apply to you. In the event of a discrepancy between these Terms of Service and the Master Services Agreement, the terms of the Master Services Agreement shall control.

B. ProsOnWeb.com Service

These Terms of Service apply to all users of the ProsOnWeb.com service. Information provided by our users through the Service may contain links to third party websites that are not owned or controlled by BNTouch.

C. BestInMortgage.com Service

These Terms of Service apply to all users of the BestInMortgage.com service. You may, but are not obligated to, establish a BestInMortgage.com directory listing if permitted by BNTouch. Information provided by our users through the Service may contain links to third party websites that are not owned or controlled by BNTouch.

D. eSignature Service

These terms of Service apply to all users of the eSignature service. Users of the Service may be given access to tools that are specifically designed for collection and processing of signatures electronically, pursuant to the ESIGN act and state law. If you use the eSignature services, it is necessary that you and all other parties to any contemplated transaction accept additional terms to consent to use of electronic

signatures in a transaction. Such additional terms are between various users of the Service, not between you and BNTouch, and BNTouch is not a party to any transaction you may conduct involving the eSignature services. BNTouch is not responsible for links to third-party websites or terms made available through the eSignature service.

E. Other Services

BNTouch will make the Service available to you pursuant to these Terms of Service. In the event you enter into another relationship with BNTouch, or your access to the Service is pursuant to another provision of services, the terms of any other written agreement between you and BNTouch will govern in the event of conflict.

3. Your Rights and Obligations

A. Generally. You may access and use the Service solely in accordance with these Terms. You agree to adhere to all laws, rules, and regulations applicable to your use of the Service.

You are the owner and controller of all of the Content you submit to the Service. You are solely responsible for determining the suitability of the Service in light of the type of your needs. You shall use reasonable security precautions in light of your use of the Service. If, in your judgment or under applicable law, your Content requires encryption or security measures that are not available on the Service, you agree to not transmit such Content to the Service.

In addition to the foregoing obligations, you acknowledge that you are solely responsible for taking steps to maintain appropriate security, protection and backup of your Content. BNTouch makes no other representation regarding the security of your Content. You are responsible for obtaining and maintaining all telecommunications, broadband and computer hardware, equipment and services need to access and use the Service and paying all charges related thereto.

B. Valid and Accurate Information. Each person who uses the Service must have a separate username and password, if one is required. You must provide your own valid email address and any other information requested by BNTouch in order to complete the signup process. You may only create one account per email address.

You agree to provide accurate and complete information when you register with and as you use the Service. You also agree to update your account information, as necessary to keep it accurate and complete. Failure to provide and maintain accurate, current, and complete account information may result in suspension or termination of your account.

C. Password Security. You are responsible for keeping your password and any access code or other verification device confidential, and, except as otherwise provided herein, you agree not to transfer your username or password to any third party. You agree to notify BNTouch immediately if you believe that an unauthorized third party may be using your account or if your account information is lost or stolen.

You are fully responsible for all activity that occurs in connection with your your account, regardless of whether the activities are undertaken by you, a user or a third party. BNTouch will not be liable for any loss or damage arising directly or indirectly from your failure to maintain the security of your account and password or for unauthorized access to your account.

D. Content Security. Because it is not possible to guarantee data security, you acknowledge that it may be possible for an unauthorized third party to access your Content, and you agree that, in such event, any loss that you may suffer is subject to the limitation of liability section of these Terms.

E. Your Additional Responsibilities. Solely you shall:

(i) Be responsible for your Content (even if Content is posted by others sharing projects under your account);

(ii) If applicable, be responsible for users' compliance with these Terms;

(iii) Be responsible for the accuracy, quality and legality of your Content and

of the means by which you acquired your Content, including ensuring, without limitation, that your Content does not infringe upon or violate the rights of any person;

(iv) Ensure compliance of your Content with these Terms and the law; (v) Handle any claims relating to your Content; and

(vi) Properly, and in accordance with applicable law, handle, process, and respond to notices sent to you by any person claiming that your Content violates such person's rights.

F. Prohibited Activities. Unless you have our express written consent, you shall not, and shall not attempt to:

(vii) Use the Service to submit, store, transmit or process malicious code, worms or viruses

(viii) Use the Service to submit, store, transmit or process Content that is or may be: (a) threatening, harassing, degrading, hateful or intimidating; (b) libelous or defamatory; (c) fraudulent, tortious or unlawful; (d) obscene, indecent, pornographic or otherwise objectionable; or (e) infringing of any person's rights, any applicable laws or your obligations to any third party;

(ix) Use the Service to submit, store, transmit or process Content that would give rise to criminal or civil liability or that encourages unlawful activity;

(x) Gain unauthorized access to the Service or to BNTouch's or BNTouch's customers' systems or networks;

(xii) Publish or disclose any benchmarks of the Service to third parties;

(xiii) Interfere with or disrupt the integrity or performance of the Service or third-party Content contained therein;

(xiv) Impersonate any person or entity or misrepresent you affiliation with any person or entity in connection with the Service;

(xv) Modify, alter, tamper with, repair, or create derivative works of any software included in the Service, unless the software is provided to you by BNTouch under a separate license that expressly permits the creation of derivative works;

(xvi) Reverse engineer, disassemble, or decompile the Service or apply any other process or procedure to derive the source code of any software included in the Service;

(xvii) Copy, frame or mirror any part or content of the Service, except with the express written consent of BNTouch;

(xviii) Access the Service in order to (a) build a competitive product or service, or (b) copy any features, functions, or graphics of the Service; or

(xix) Remove any copyright, trademark or other proprietary rights notice from the Service.

G. Use of Bots Prohibited. You agree not to use or launch any automated system, including without limitation, "robots," "spiders," "offline readers," etc. or "load testers" such as wget, apache bench, mswebstress, httpload, blitz, Xcode Automator, Android Monkey, etc., that accesses the Service in a manner that sends more request messages to the Service in a given period of time than a human can reasonably produce in the same period by using the Service, and you are forbidden from ripping the content without prior written consent of BNTouch. using request modification tools such as fiddler or whisker, or the like or any other such tools activities that are meant to explore or harm, penetrate or test the site. You must secure our permission before you measure, test, health check or otherwise monitor any network equipment, servers or assets hosted on our domain. You agree not to collect or harvest any personally identifiable information, including phone number, from the Service, nor to use the communication systems provided by the Service for any commercial solicitation or spam purposes.

H. Adherence to Acceptable Use Policy. BNTouch provides some users with the rights to send emails to other users via its services partner MailGun. Use of email services must at all times comply with MailGun's acceptable use policy, found here <https://www.mailgun.com/aup/>. BNTouch cannot control and is not responsible for MailGun's email service. MailGun reserves the rights to update its acceptable use policy from time to time, and BNTouch users are advised to review the acceptable use policy regularly to ensure they adhere to its provisions.

I. Right to Monitor. BNTouch has the right to review and monitor all use of the Service to ensure compliance with all of these Terms, and to evaluate the performance of the Service. BNTouch also has the right to analyze user behavior to evaluate use of the Service, both on an individual basis and in the aggregate, and otherwise to collect, create, and analyze metadata about your use of the Service provided that such metadata is never disclosed to any third party other than in anonymized or aggregate format.

4. Intellectual Property Rights

A. Reservation of Rights. C. Your Suggestions. You hereby grant to BNTouch all right, title and interest in and to any Suggestions that you make regarding the Service. In the event your grant herein is not sufficient for BNTouch to fully realize and use the Suggestions, you grant to BNTouch a royalty-free, worldwide, transferable, sub-licensable, irrevocable, perpetual license to use and incorporate into the Service any of your Suggestions. BNTouch shall be under no obligation to use, or retain, your Suggestions.

5. User Status Submissions

A. ProsOnWeb.com allows users to submit Content including status text, documents and other communications submitted by you, as well as the automatic entry of use information such as your "last visited" status (collectively, the "Status Submissions"). These Status Submissions are hosted and shared with your Professionals as part of the ProsOnWeb.com portion of the Service.

B. You shall be solely responsible for your own Status Submissions and the consequences of posting or publishing them. D. BNTouch reserves the right to discontinue any aspect of ProsOnWeb.com at any time.

6. BNTouch's Additional Rights

A. Access to and Use of Your Content. By submitting or posting your Content on the Service, you grant

BNTouch a worldwide, royalty free, non-exclusive license to access, make use of, and copy, distribute or perform (including modifications and derivative works) such Content on the Service solely for the purposes of offering and supporting the Service. For example, BNTouch may access the Content to

In no event will you settle any claim or action without prior written approval.

11. General

You agree that: (i) the Service shall be deemed solely based in Oregon; (ii) the Service shall be deemed a passive server that does not give rise to personal jurisdiction over BNTouch, either specific or general, in jurisdictions other than Oregon; and (iii) that you agree to subject to the jurisdiction of Oregon in the event of any legal dispute. These Terms of Service shall be governed by the internal substantive laws of the State of Oregon, without respect to its conflict of laws principles. Any claim or dispute between you and BNTouch that arises in whole or in part from the Service shall be decided exclusively by a court of

competent jurisdiction located in Portland, Oregon. These Terms of Service, together with the Privacy Policy at <http://BNTouchMortgage.net/Privacy> and any other legal notices published by BNTouch, including, but not limited to an end user license agreement, along with any order form or services agreement, shall constitute the entire agreement between you and BNTouch concerning the Service. If any provision of these Terms of Service is deemed invalid by a court of competent jurisdiction, the

invalidity of such provision shall not affect the validity of the remaining provisions of these Terms of Service, which shall remain in full force and effect. No waiver of any term of this these Terms of Service shall be deemed a further or continuing waiver of such term or any other term, and BNTouch's failure to assert any right or provision under these Terms of Service shall not constitute a waiver of such right or provision. BNTouch reserves the right to amend or modify these Terms of Service at any time, and it is your responsibility to review these Terms of Service for any changes. If you do not agree to the revised Terms, your only recourse is to discontinue the use of the Service. It is your responsibility to keep your email address current. You will be deemed to have received any email sent to the email address then associated with our account when BNTouch sends the email, whether or not you actually receive the email. **YOU AND BNTOUCH AGREE THAT ANY CAUSE OF ACTION ARISING OUT OF OR RELATED TO THE SERVICE MUST COMMENCE WITHIN ONE (1) YEAR AFTER THE CAUSE OF ACTION ACCRUES. OTHERWISE, SUCH CAUSE OF ACTION IS PERMANENTLY BARRED.**

12. DEFINITIONS

"Affiliate" means any entity that directly or indirectly controls, is controlled by, or is under common control with the subject entity. "Control," for purposes of this definition, means direct or indirect ownership or control of more than 50% of the voting interests of the subject entity.

"BNTouch Content" means the Content that BNTouch makes available in connection with the Service or on the sites or tools controlled by BNTouch and subject to these Terms, including use instructions or documentation; software libraries; command line tools; and other related technology if provided by BNTouch. BNTouch Content does not include the Service.

"Content" means material, information, software (including machine images), data, text, audio, music, sound, video, images, photographs, graphics, messages, files, attachments, or other materials.

"Professional" refers to users authorized by a BNTouch Mortgage CRM customer to access the Service using the ProsOnWeb.com tools.

"Suggestion" or "Suggestions" means any suggested improvement or enhancement to the Service, and any recommendation or other feedback with respect to the Service or BNTouch.

"Third Party Content" means Content made available to you by any third party on websites or apps controlled by BNTouch or otherwise in conjunction with the Service.

"User" means "You" and any individual whom you authorize to use the Service, when you have supplied such individual with your user identifications and passwords for your account. A "User" may include your employee, consultant, contractor or agent.

"Your Content" means Content other than BNTouch Content or Third Party Content that is input, uploaded, posted, or otherwise created or made available by you within the Service.
